RENTAL AGREEMENT

Terms and Conditions

INFORMATION: You promise information furnished is true and complete. Information will be relied upon in establishing your account and to conduct business. You agree to inform Antonio Strad Violin as soon as you know of any changes on your billing or contact information by phone or in writing

RENTAL TERMS: Renter pays the first and last month's rent in the initial payment. Rental automatically renews every month on the same date as the initial rental date or on the date indicated on this agreement. Renter must contact us in advance of the last billing cycle to terminate the contract and to apply the last month's rent from the initial payment. No fees will be refunded. The instrument must be returned **before** the next due date to avoid the next month's rental bill. Returns must be made to our store. The instrument may be exchanged for a larger or finer one at any time. The minimum rental charge is one month. Rentals less than two months pay a \$15.00 restocking fee.

PROTECTION PLAN: Antonio Strad Violin will repair or replace the covered instrument, bow, and case with items of comparable quality and condition for accidental damage, fire, or theft by forced entry (with a copy of the city police report within 14 days of the theft). There is no deductible. **The Protection Plan will not cover an account if it is 30 days past due.** Excluded from the Protection Plan are strings, cosmetic damage not impeding the tone or playability of the instrument, loss due to negligence, damage by a shoulder rest, repair by an unauthorized person, intentional abuse, or vandalism.

PAYMENT: Renter promises to pay for all rent plus any other charges that may be assessed as provided in this agreement. A late charge of \$2.00 is added on each late payment and \$ 26.97 will be added for each returned payment. If delinquent: more than 30 days, Renter authorize Antonio Strad Violin to charge delinquent amount to renter's credit card or bank account; more than 60 days, then Renter authorizes Antonio Strad Violin to pick up the rented instrument at school, or at other locations. The rental is property of Antonio Strad Violin. If Renter's account is sent to a collection agency, Renter will be responsible for the purchase of instrument, any delinquent balance, legal expenses, and collection expenses, etc.

OPTIONS: Renter will accrue 100% credit for **on time rental fees** (not including Protection Plan) toward the purchase of this or a finer instrument outfit when the account is current and the outfit is returned in the original condition. The optimum discount is 80% credit allowed towards the purchase of the rented outfit. Rental credit may also apply to a finer instrument outfit purchase or an upgraded rental instrument up to half of the purchase price. Discounts are not held for future application. **This purchase option is not automatic; it is the customer's option to exercise.** (By written notice or in person)

PURCHASED ACCESSORIES: Returns need original receipt, packaging, and be in perfect condition within 30 days.
